RESOLUTION 2021-29

A RESOLUTION OF THE BOARD OF SUPERVISORS OF COCONINO COUNTY, ARIZONA, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO DECLARE THE EXISTENCE OF AN EMERGENCY OR LOCAL EMERGENCY PURSUANT TO A.R.S. § 26-311

WHEREAS, A.R.S. § 26-311 allows the Board of Supervisors to give authority, by resolution or ordinance, to its Chairperson to declare by proclamation the existence of an emergency or a local emergency; and

WHEREAS, A.R.S. § 26-311 allows such authorization to be granted for emergencies due to fire, conflagration, flood, earthquake, explosion, war, bombing, acts of the enemy or any other natural or man-made calamity or disaster or by reason of threats or occurrences of riots, routs, affrays, or other acts of civil disobedience which engender life or property within the unincorporated areas of the county, or portion thereof; and

WHEREAS, upon the declaration of an emergency, the chairperson has the authority to govern by proclamation and has the authority to impose all necessary regulations to preserve the peace and order of the unincorporated areas of the county; and

WHEREAS, the declaration of an emergency allows counties to utilize additional resources from the State and federal government, and seek mutual aid from other jurisdictions to address the emergency and its impacts;

WHEREAS, Coconino County frequently experiences emergencies such as fires and floods and may experience other emergencies in which an immediate response is more effective than a response that requires action of a quorum of the Board of Supervisors and the associated notice requirements prior to such action; and

NOW THEREFORE BE IT RESOLVED, that the Coconino County Board of Supervisors authorizes the Chairperson of the Board to by proclamation declare an emergency or a local emergency to exists and to take any other actions as authorized by A.R.S. § 26-311.


