A RESOLUTION OF THE BOARD OF SUPERVISORS OF COCONINO COUNTY, ARIZONA, DESIGNATING BALLOT DROP BOX LOCATIONS FOR 2020 GENERAL ELECTION

WHEREAS, the Coconino County Board of Supervisors is required by Arizona Revised Statutes Section 16-411 to designate polling locations for the General Elections; and

WHEREAS, the Board of Supervisors wish to provide additional convenience to voters by designating Ballot Drop Box locations in the County where any registered voters in the County will be able to drop off their ballot;

NOW, THEREFORE, BE IT RESOLVED that the Coconino County Board of Supervisors does hereby designate the locations listed in Exhibit "A" as Ballot Drop Box locations for the General Elections conducted in 2020.

NOW, THEREFORE, BE IT FURTHER RESOLVED if a Ballot Drop Box location needs to be changed prior to the elections, the County Recorder is authorized to find an alternative location in accordance with A.R.S. 16-411.


