The Board of Supervisors' meeting was held via webinar technology using Zoom. The Executive Session was held using Microsoft Teams technology.

Vice Chair Fowler called the Special Session meeting to order at 10:04 a.m.

Call to the Public:

There were no comments from the public for items not on the agenda.

7. **Separated:** Consideration and possible action to accept grant funding from the Arizona Coronavirus Emergency Supplemental Funding Program, in the amount \$287,487, for preventing, preparing for, and responding to the coronavirus. **Finance**

Supervisor Babbott asked if this grant is criminal justice focused, detention oriented?

Deputy County Manager Dr. Marie Peoples explained the funding will be used for technology, personnel protection equipment supplies.

Supervisor Ryan noted this is a unique opportunity, with a methodology of handling a maintenance piece.

Parks and Recreation Director Cynthia Nemeth noted this is a great partnership with the Navy, the grant will provide funding on an annual basis to help support management of the conservation easement and property in perpetuity.

Supervisor Ryan noted that at one time, the Board had to shift money away from this property. Federal money allowed us to move forward with acquisition and opportunities like this grant will help with the maintenance piece.
