Steven Edward Jones, the Defendant, retakes the stand. The Witness, having previously been sworn, testifies on redirect examination.

The Witness continues to testify on the Jury Questions and follow-up examination by Defense Counsel (Joshua Davidson) and the State (Bryan Shea).

There being no objection, the Witness is excused.

The Court advises it will take the luncheon recess and gives the Admonition.

1:39 p.m. Court reconvenes. The Defendant, Counsel, the investigating officer, and the Jury are present.

The Witness continues to testify on cross examination by the State (Ammon Barker).

At the Court's direction, Court and Counsel sidebar on the record.

As there are no Jury Questions and there being no objection, The Witness is excused.

At the request of Defense Counsel (Joshua Davidson), Court and Counsel hold a bench conference off the record.


