WARRANT FOR ARREST

TO ALL PEACE OFFICERS OF THE STATE OF ARIZONA:

An indictment has been filed in this court against WINSTON TYA WATSON charging that in Coconino County, Arizona:

FIRST DEGREE MURDER, a class 1 felony, in violation of A.R.S. §§ 13-1105(A)(1), 13-1101, 13-703, 13-708, 13-752 and 13-801.

SHOPLIFTING, a class 1 misdemeanor, in violation of A.R.S. §§13-1805(A)(1), 13-1801, 13-701, 13-707 and 13-802.

The court has found reasonable cause to believe that such offenses were committed and that the accused committed them, and reason to believe that the accused will not appear in response to a summons or that a warrant is otherwise appropriate.

YOU ARE THEREFORE COMMANDED to arrest the accused and bring him before this court to answer the charges. If this court is unavailable, or if the arrest is made in another county, you shall take him before the nearest or most accessible magistrate.

The offense is, or is materially related to, a Victims' Rights applicable offense, i.e., it is a felony or it is a misdemeanor involving physical injury, the threat of physical injury or a sexual offense.
