Introduction

The Arizona Department of Health Services (ADHS) has defined the following school benchmarks with corresponding recommended delivery models. All three benchmarks must be in 'minimal' for 2 consecutive weeks in order to return to in-person instruction. All three benchmarks must be in 'substantial' for 2 consecutive weeks in order to move to virtual instruction.

Benchmarks	Minimal	Moderate	Substantial
Cases	<10 cases/100,000	10-100 cases/100,000	>100 cases/100,000
Percent Positivity	<5%	5-10%	>10%
COVID-like Illness	<5%	5-10%	>10%
Recommended Delivery Model	Traditional/In-Person	Hybrid	Virtual

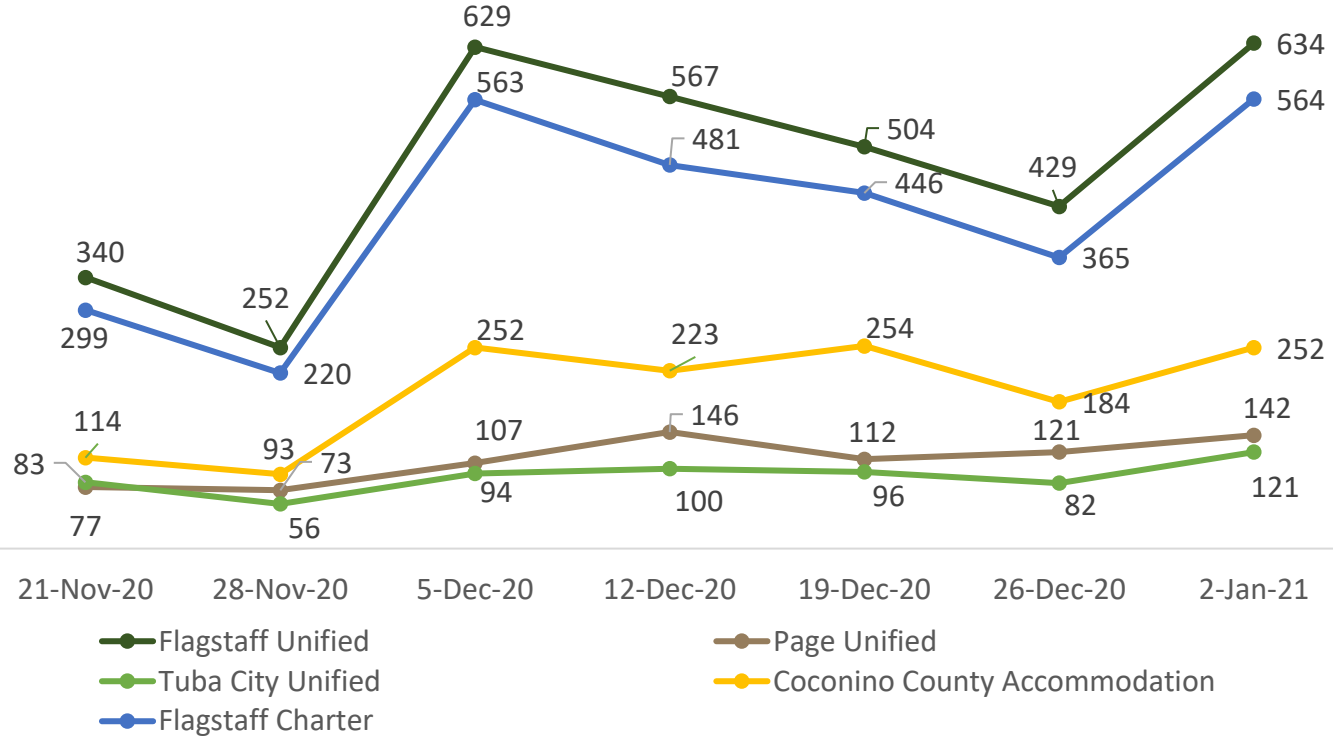

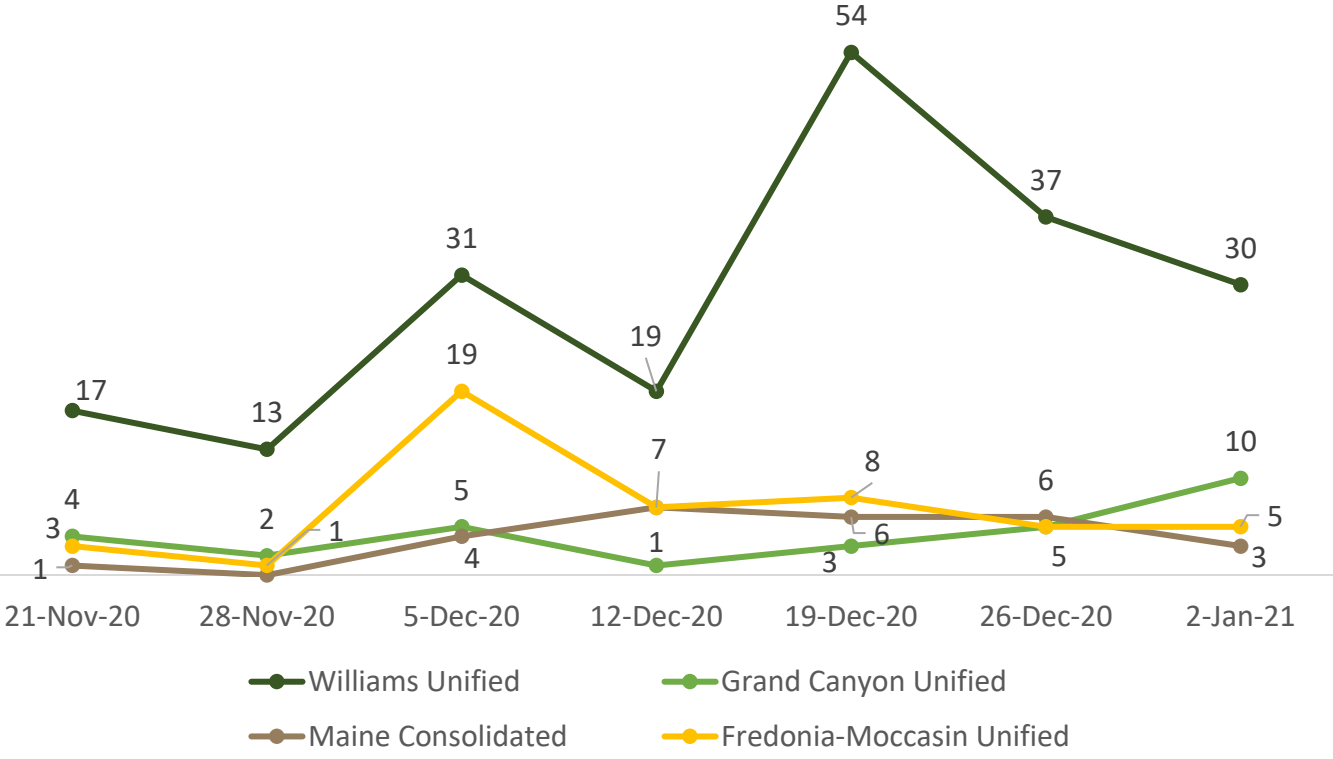

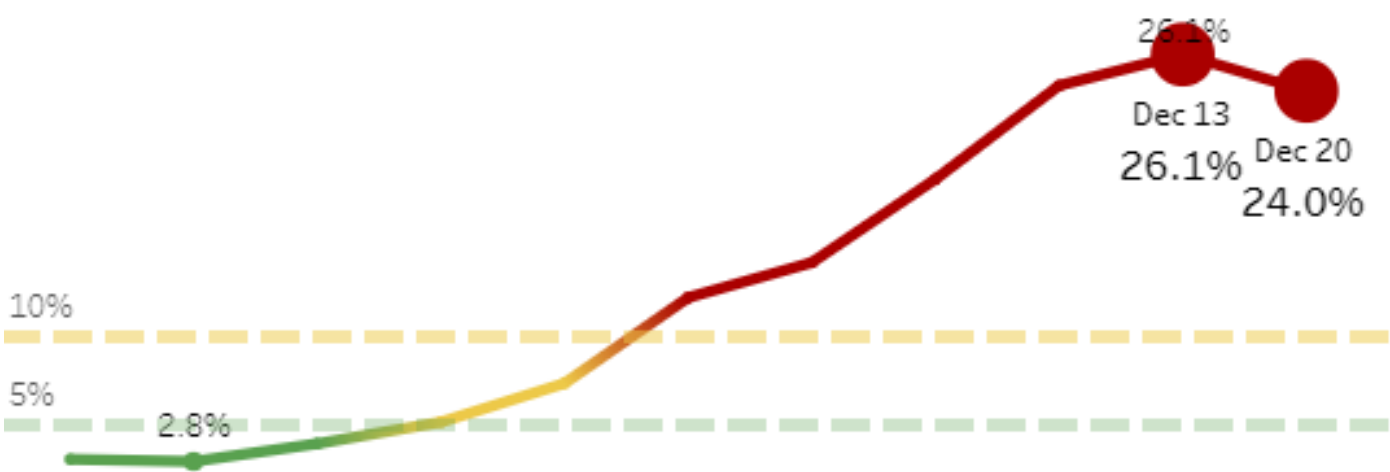

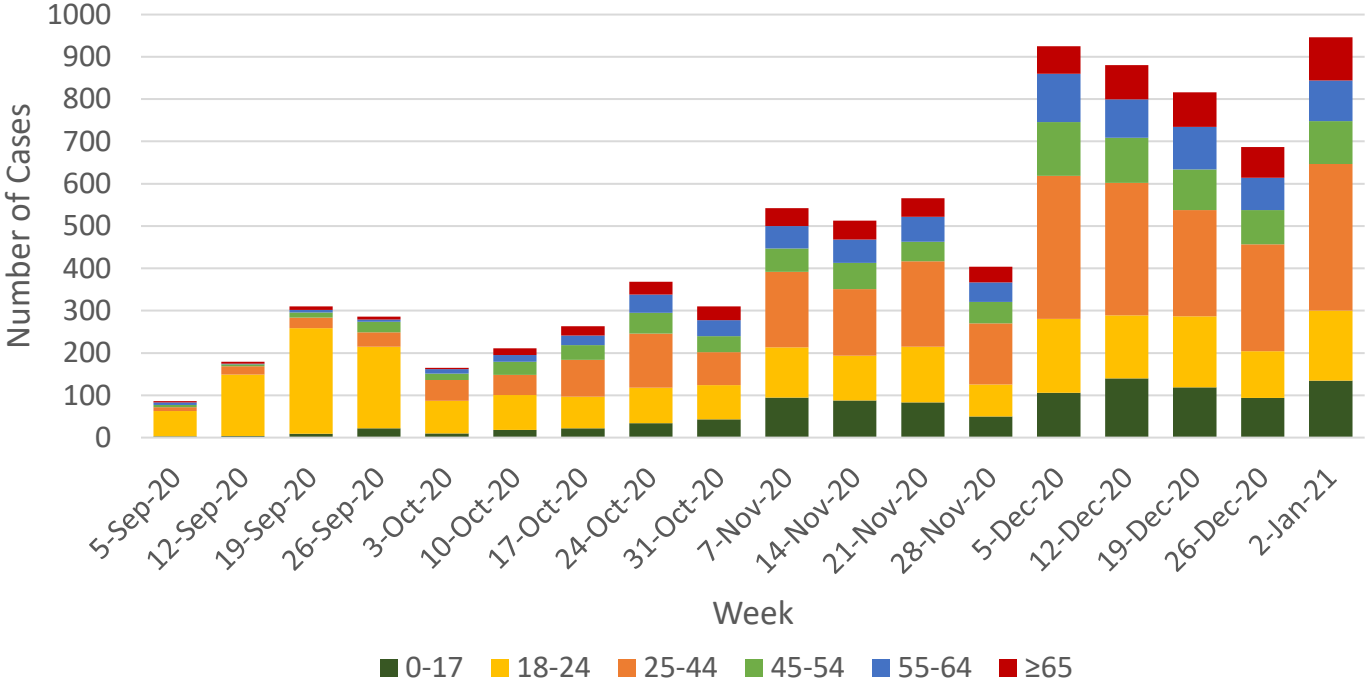
