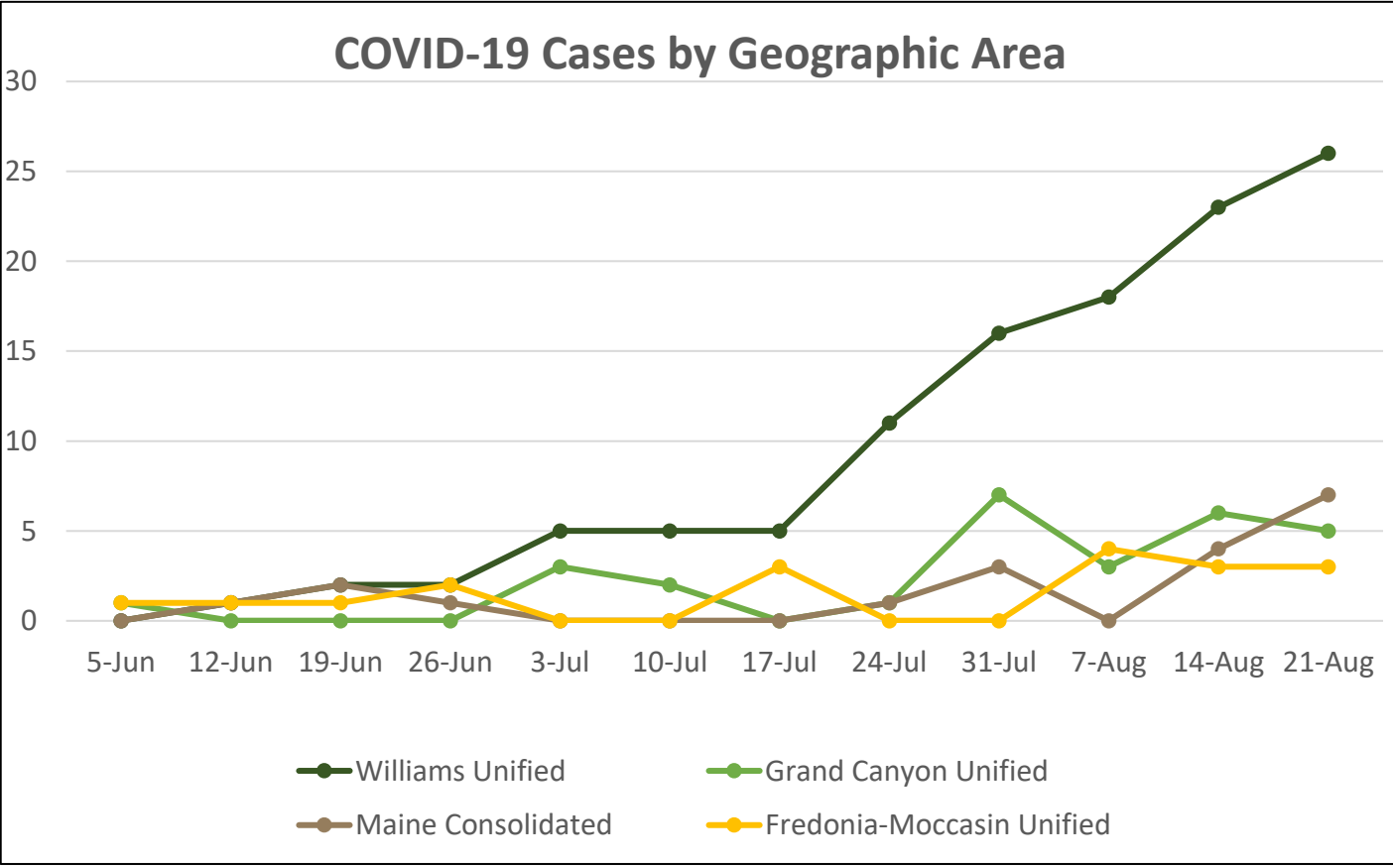
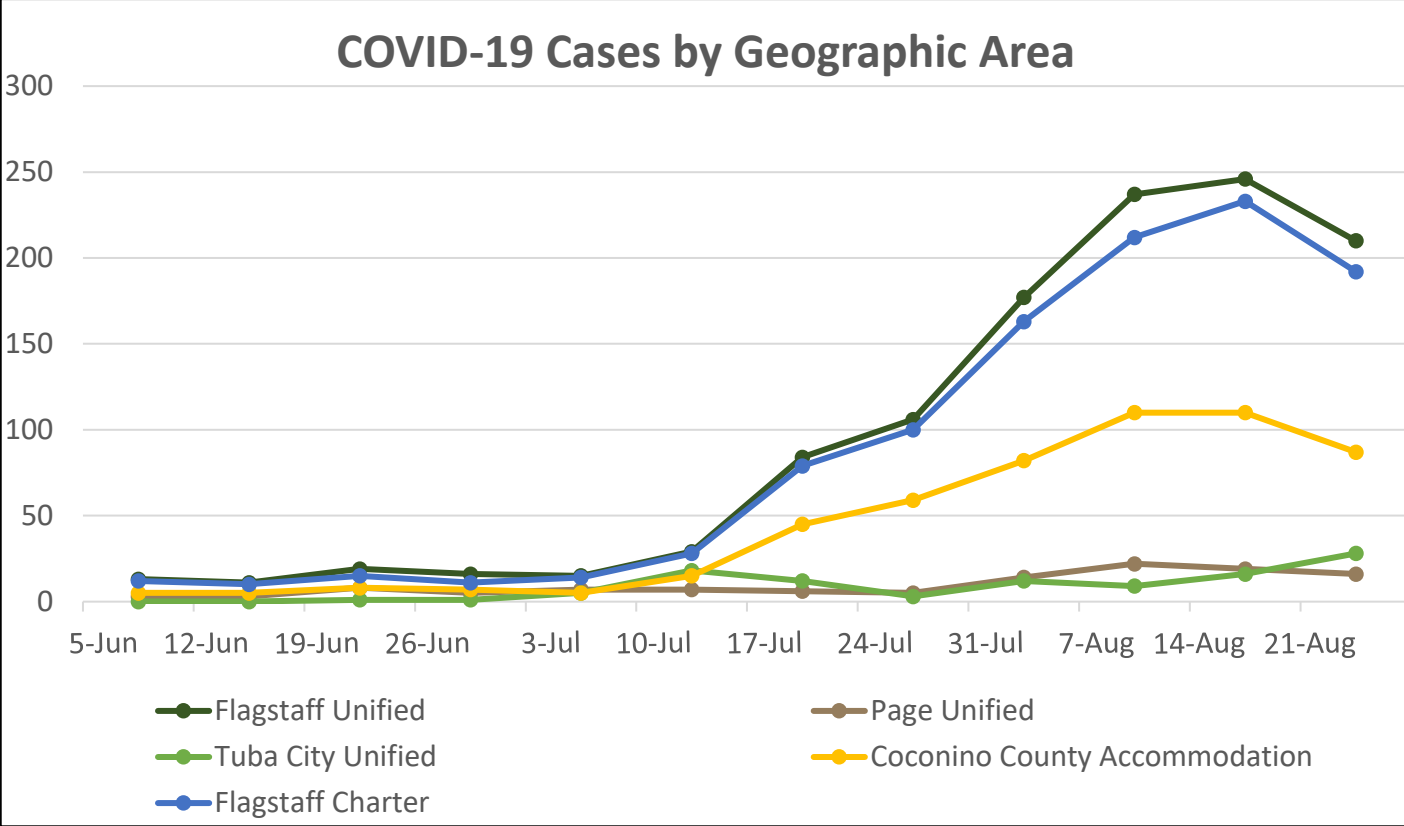

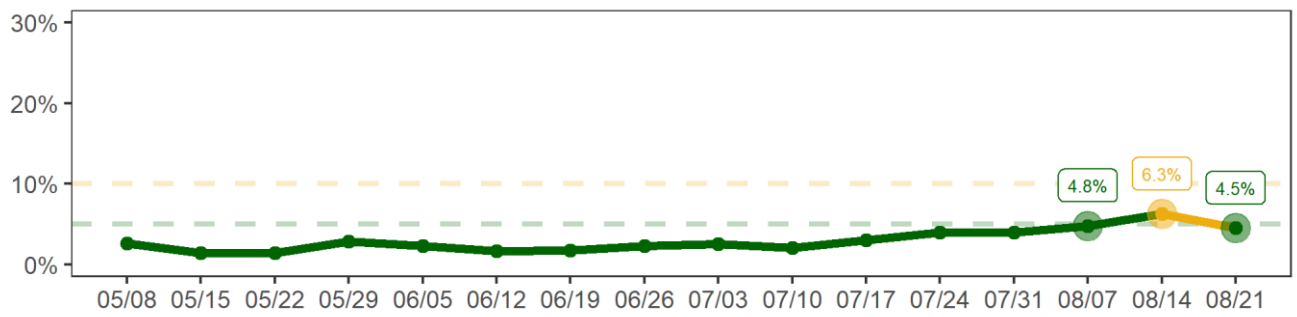

CLI Graph represents data from hospital surveillance at the county level. Not all county hospitals are reporting CLI.

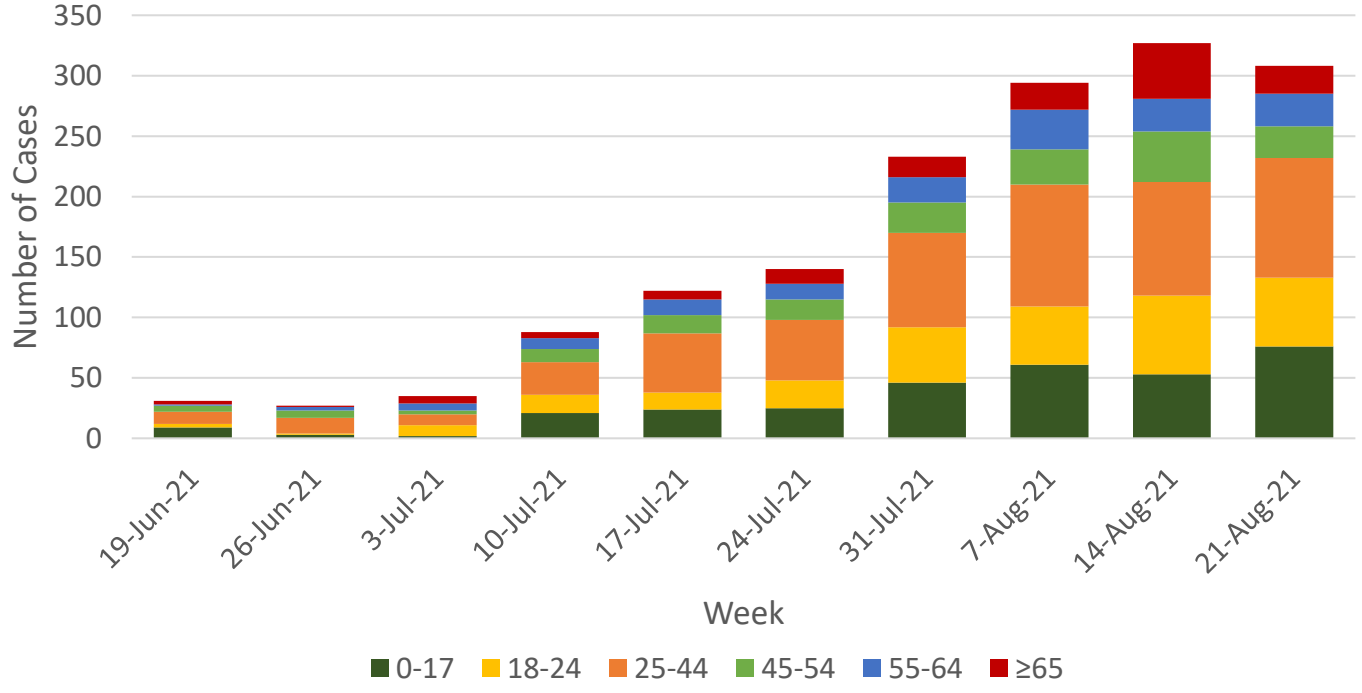
