SBA Offers Disaster Assistance to Arizona Businesses and Residents Affected by Severe Storms, Flooding, Mudslides and Debris Flows

SACRAMENTO, Calif. – Low-interest federal disaster loans are available to Arizona businesses and residents affected by severe storms, flooding, mudslides and debris flows that occurred July 23 - Aug. 28, 2022, announced [Administrator Isabella Casillas Guzman](#) of the U.S. Small Business Administration. SBA acted under its own authority to declare a disaster in response to a request SBA received from Governor Douglas Ducey on Sept. 16, 2022.

The disaster declaration makes SBA assistance available in Coconino, Gila, Mohave, Navajo and Yavapai counties in Arizona; and Kane and San Juan counties in Utah.

“SBA’s mission-driven team stands ready to help Arizona’s small businesses and residents impacted by severe storms, flooding, mudslides and debris flows,” said Administrator Guzman. “We’re committed to providing federal disaster loans swiftly and efficiently, with a customer-centric approach to help businesses and communities recover and rebuild.”

“Low-interest federal disaster loans are available to businesses of all sizes, most private nonprofit organizations, homeowners and renters whose property was damaged or destroyed by this disaster,” said SBA’s Director Tanya N. Garfield of the U.S. Small Business Administration’s Disaster Field Operations Center-West. “Beginning Tuesday, Sept. 20, SBA customer service representatives will be on hand at the following Disaster Loan Outreach Center to answer questions about SBA’s disaster loan program, explain the application process and help each individual complete their application,” Garfield continued. The center will be open on the days and times indicated below. No appointment is necessary.

Businesses of all sizes and private nonprofit organizations may borrow up to \$2 million to repair or replace damaged or destroyed real estate, machinery and equipment, inventory and other business assets. SBA can also lend additional funds to businesses and homeowners to help with the cost of improvements to protect, prevent or minimize the same type of disaster damage from occurring in the future.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size, SBA offers Economic Injury Disaster Loans to help meet working capital needs caused by the disaster. Economic injury assistance is available regardless of whether the business suffered any property damage.

Disaster loans up to \$200,000 are available to homeowners to repair or replace damaged or destroyed real estate. Homeowners and renters are eligible for up to \$40,000 to repair or replace damaged or destroyed personal property.

Interest rates can be as low as 2.935 percent for businesses, 1.875 percent for private nonprofit organizations and 1.688 percent for homeowners and renters with terms up to 30 years. Loan amounts and terms are set by SBA and are based on each applicant's financial condition.

The deadline to apply for property damage is Nov. 18, 2022. The deadline to apply for economic injury is June 19, 2023.
