TO REQUEST AN INSPECTION:

Option 1: Call the assigned Inspector for your areas Office Phone. **Supply the following information:** Parcel Number, name of the subdivision, lot & unit number, permit number, street address, the date you are requesting an inspection for, the type of inspection being requested and a return phone number. Phone requests must be made by 3:00p.m. the day prior to your desired inspection.

Option 2: WEB PORTAL @ www.coconino.az.gov The same information will be required. Do not forget to select your desired date of inspection. Check the web portal to verify that your inspection has been scheduled. You may also check the web portal for inspection results. Inspection requests made on the Web Portal must be made by 3:00p.m. the day prior to your desired inspection.

NO REQUESTS FOR A SPECIFIC TIME OF DAY CAN BE HONORED UNTIL CONFIRMED BY THE INSPECTOR.
